PREAMBLE

To implement the dispositions of the Co-operation Agreement between the Government of the Republic of Poland and the Government of Flanders, that was signed in Warsaw on the 6th of June 1994, the Government of the Republic of Poland and the Government of Flanders, hereafter called the Parties,

have agreed as follows, for the years 2021 - 2023:

1. IN GENERAL

1.1. WO II Memorial in Roeselare and permanent expo in Poznan

Poland and Flanders (further as both Parties) will assist the local authorities of Roeselare in creating a Memorial about the liberation of Flanders by the First Polish Armoured Division. If necessary, both Parties will also support parallel initiatives such as a route through the liberated Flemish cities and a wall of fame with an indication of all fallen Polish soldiers.

An opening in March 2022 to mark the birthday anniversary of General Maczek's 130th birthday would be ideal.

Flanders donated the 'Armoured wings' exhibition to the Tank Museum in Poznan. The Flemish Party has agreed with the museum that the exhibition will have a permanent character and will tell the story of the liberation of Flanders by the First Polish Armoured Division. If conditions permit, an opening event will be organized in cooperation with the General Representative of the Government of Flanders.

1.2. Anniversaries or historical events

1.2.1 General Stanisław Maczek

On account that in 2022 we will be celebrating the 130th birthday anniversary of General Stanisław Maczek, it is the chief intention of the Polish Embassy in Belgium, one which has already been discussed with many partners, from Poland and Flanders, to effect the creation of a memorial to General Maczek in the Kingdom of Belgium. The authorities of the town of Roeselare has agreed to provide a location for this purpose – post-German bunker from the period of II World War.

Flemish partners in this project would include the Association of the First Polish Armoured Division Belgium (Vereniging 1e Poolse Pantserdivisie Belgie vzw), representatives of Roeselare authorities and the 'Polish Memorandum' association.

The partners on the Polish side would include: the Ministry of Foreign Affairs, the Ministry of Culture, National Heritage and Sport, the Ministry of National Defence, the Office for War Veterans and Victims of Oppression, the Institute of National Remembrance and the Polish History Museum.

Both parties will look into further ways to contribute to the commemoration of the efforts made by the soldiers of the Polish 1st Armoured Division commanded by General Maczek in the liberation of Flanders from German occupation in September 1944 through carrying out joint projects to that end.

1.2.2 Great Emigration

The year 2021 will mark the 190th anniversary of the beginning of the Great Emigration of Poles to Belgium and the 160th anniversary of the death of J. Lelewel, a prominent historian, numismatist and political activist, who settled in Belgium in 1833. These anniversaries will serve as an opportunity to recall the role and scientific achievements of the famous Pole by organising an exhibition dedicated to

the Great Emigration, with J. Lelewel being one of its most prominent figures; the exhibition is to be shown in Warsaw, Brussels, Paris and Vilnius.

1.2.3 Maria Skłodowska-Curie

• The period 2021–2023 will mark anniversaries associated with M. Skłodowska-Curie which will provide a very good opportunity to take joint action to offer a closer look (in the form of a conference or otherwise) at the relationship that the Polish Nobel Prize winner had with Belgium, including her scientific contacts. We will invite to join the project: R. Debaillie, author of the book about M. Skłodowska-Curie and I. Curie entitled La brave petite Belgique; D. Zędzian, author of the study Polish Traces in the History of Belgium and B. Van Tiggelen of the Catholic University of Leuven; Among the partners of the project would be the authorities of Veurne.

1.2.4 Holocaust and Human Rights

- The year 2023 will mark the 80th anniversary of the Warsaw Ghetto Uprising and it would be
 important for both sides to prepare a joint project commemorating this event with the
 involvement of the Polin Museum, the Warsaw Ghetto Museum and the Jewish Museum in
 Brussels and in cooperation with Jewish organisations from Flanders, especially from Antwerp.
- The Embassy plans to again become involved in the preparations for the cyclical project 'Train
 des mille' organised by the War Heritage Institute and the Memoire d'Auschwitz Association
 in Brussels. It is an educational project for young people, which ends with a several-day 'train
 of remembrance' from Brussels to Auschwitz-Birkenau.

1.3. Outreach in Flanders and Poland

The Polish Party will continue to cooperate within the framework of cyclical events promoting a positive image of both countries, thus contributing to the dynamics of cultural, sports and scientific ties. The Polish Partner cooperates with several Polish and Flemish partners.

These events are Polish Culture Days in Roeselare (September) and Polish Days in Antwerp (June), Ghent (November), Bruges (May) and Adegem (September).

Poland also encourages the Flemish partners to support the organisation of next editions of the 'Polish Run', a run regularly jointly organised by the Embassy of the Republic of Poland in Brussels and the East Poland House in Brussels as part of the European Week of Sport.

Flanders intends to organize in 2023 a 'Flemish week' in a Polish city with the cooperation of Polish and Flemish partners.

The exhibition 'Armoured wings' was an implementation of the last working programme; The Flemish Party has donated the exhibition to the Tank Museum in Poznan. Covid-19 has so far prevented an official opening that could take place from autumn 2021

3.2. Educational institutions

The Polish Institute in Brussels collaborates with the History Institute of the Jagiellonian University and with the Faculty of Arts and Philosophy (Faculteit Letteren en Wijsbegeerte) of the University of Antwerp. The parties involved have launched the initiative of elaborating a programme of joint workshops and lectures for history students of both universities. The project has two objectives: 1. To broaden the students' knowledge of the history of Polish and Flemish cities from the Middle Ages until the present day using the newest research perspectives and teaching methods; 2. To integrate Polish and Flemish students and faculty members by creating appropriate conditions for sharing experiences and views and for dialogue within an international group. The detailed scientific programme of the weekly workshops in Kraków and in Antwerp, involving students from both universities, has been prepared by representatives from the Jagiellonian University and the University of Antwerp.

<u>The College of Europe</u> has a campus in Flanders (Bruges) and Poland (Natolin). Flanders awards each academic year a scholarship for a student in Natolin who comes from a country of the Eastern Neighbourhood.

The Flemish Party is very pleased by the continued interest of Polish young people in the study of Dutch (+700 students). The knowledge of the Dutch language offers multiple opportunities for cooperation in areas such as economic development and scientific research.

The Flemish side is interested to support the Dutch studies at different Polish universities together with the Dutch-Flemish organisation for promotion of the Dutch language "The Taalunie" (de Taalunie) & the Embassy of the Kingdom of the Netherlands in Poland. Embassy of Belgium Delegation of Flanders will therefore actively take part in the supporting mechanism OPON (cooperation of Dutch faculties at Polish universities, the Embassy of the Kingdom of the Netherlands and Embassy of Belgium Delegation of Flanders).

The departments involved can count on the assist of <u>The Taalunie</u>, such as support to academic networks, basics grants for Dutch departments, guest speakers and guest writers, scholarship funds, project grants (academic, didactic and cultural), summer courses for teachers and students, support and workshops on literary translation and a new platform (from Autumn 2021) "Mijn Nederlands" ("My Dutch") with online access to information, grants, resources, courses, contacts & networks.

The Taalunie will co-operate with the University of Wroclaw to subtitle movies. A workshop will be organised in the autumn of 2021.

6. SOCIAL POLICY AND THE LABOUR MARKET

6.1. The Polish Party proposes establishing cooperation in the following areas:

- Exchange of information and experience on counteracting the effects of unemployment:
- Forms and methods of combating unemployment during an economic recession;
- Exchange of experiences concerning the effectiveness of various forms of support for the unemployed and methods of their activation as well as concerning forms of supporting quality jobs creation.

Exchange of experiences concerning the labour market may be particularly relevant in connection with the anticipated changes in this area, resulting from the declared state of epidemic and the related freezing of the economy, as well as seeking new solutions in the field of labour market policy.

Regarding the urgency to implement the principles of sustainable development, in order to ensure the quality of jobs and the need to develop a low-carbon economy, it would also be advisable to exchange experiences (between institutions, employers), on the one hand, in the field of solutions for the creation of safe work environments and counteracting discrimination on the labour market, and on the other – in the field of creating 'green jobs'.

6.2. The project "Pomorskie! I'm coming back here, I'm working here"

Cooperation in the promotion of the project 'Pomorskie! I'm coming back here, I'm working here. The project is implemented in the period 01.10.2019 – 31.03.2022 and concerns cooperation with 8 EU/EEA countries, including Belgium. The aim of the project is to support the return of Poles living and working abroad, including in Belgium, who plan to return to the country to settle and take up employment in the Pomorskie Voivodeship. Project participants will receive support such as:

- Preparation of an individual action plan adjusted to the needs and predispositions of the participants,
- Free vocational courses and trainings in one of the selected industries,
- Certificates confirming qualifications recognized in the industry,

- Job placement and support in employment with a reliable employer,
- Support in adaptation in the new place of residence.
- Psychological and legal support if necessary,
- Training scholarship,
- Translation of foreign documents to confirm professional qualifications,
- Reimbursement of travel expenses during counseling, training, as well as childcare costs during the training.

This is the area that involves cooperation with EURES advisers from Belgium. Their task is to help promote the project and disseminate information about it among the Poles living in Belgium and the Polish clients of Belgian labour offices.

The objective of the project 'Public administration support for the research and development sector' is to exchange experiences concerning public support and coordination in developing the research and development sector. Ongoing globalisation processes contribute to decreasing competitiveness of the European Union economy. In order to counteract this phenomenon, it is crucial for the European Union and its Member States to advance the research and development sector which contributes to creating innovative products and services. Launching modern products/ services

requires a knowledge-based economy, specialised in specific future-oriented areas, such as biochemistry, IT, robotics, pharmaceutics, etc.

14. INVESTMENT AND TRADE

14.1. Initiatives and sectors of mutual economic cooperation

Flanders is the main partner in the Polish-Belgian trade. In this context, it is important to enhance mutual economic cooperation, especially in the fields of trade and investments. It will be important to engage in promoting trade relations through regular trade fairs (if they can be planned), including agrifood, building and construction, fashion, furniture and transportation fairs, etc., and also in organising trade missions, matchmaking sessions (B2B), study visits of representatives of business, chambers of commerce, trade agencies, science organisations and public administration from Flanders and Poland (both at government and local level) as well as events dedicated to export and investment conditions in both countries.

Regarding the implementation of the foreign expansion objectives contained in the Polish Strategy for Responsible Development, Poland is particularly interested in boosting Polish investments in Flanders and also in increasing Polish exports to this region with assistance and cooperation with the Polish Investment and Trade Agency (PAIH). Cooperation between Polish and Flemish SMEs is of particular significance, especially in sharing experience in internationalization of SME's.

Flanders Investment & Trade (FIT) organises site-visit programmes to Flanders for Polish companies which consider investment in the region". Of course our counter parts at PAIH can point interested companies in our direction, we do the same when Flemish companies are interested in investing in Poland.

The promising sectors that may significantly contribute to boosting mutual economic cooperation include, on the Polish side, sectors of particular importance to the Parties, including: agri-food, furniture, construction and logistics, energy and e-mobility.

Within its export promotion strategy, FIT focuses on the following promising target sectors in Poland. Construction and building materials, food and retail, environment renewable energy, logistics and storage, healthcare - elderly care, finance - EU funds, ICT and FinTech, drones, gaming and e-mobility.

Furthermore, the VLAM (Flemish Center for Agro & Fisheries Marketing) focuses on the products of the Flemish agricultural, horticultural and fishing sectors.

- The Flemish Party is committed to enhancing and promoting trade relations between Poland and Flanders. For that purpose, the partners will exchange information regarding business and investment opportunities. Both sides may offer the exchange of information regarding its market and sectors, useful contacts, experience and knowledge in the field of promoting international entrepreneurship.
- Given the experience and achievements of Flanders in the field of innovation policy, including support for artificial intelligence, and cooperation within clusters, as well as other activities aimed at developing Industry 4.0., Poland would also be interested in further exchange of experience and launching joint undertakings in this area.

Intensification, with the support of Flanders Investment & Trade (FIT) of economic cooperation between Poland and Flanders, with emphasis on extremely important medical technologies, particularly in telemedicine or in the cultural and creative sector. The appropriate partner for the last sector is Flanders DC of Flanders District of Creativity.

The launch in 2017 of the economic prize 'Eagle of the Economy', awarded by the Ambassador of the Republic of Poland to the Kingdom of Belgium to Flemish companies actively operating on the Polish

market, is a good example of strengthening business cooperation between Poland and Flanders. The Polish side express the willingness to continue cooperation with the Flemish partners in selecting candidates and organizations to participate in this prestigious annual event attended by high-ranking politicians or businessmen from both countries.

Both Parties will continue to attach a special importance to regional economic cooperation by establishing new partnerships between regions, cities and municipalities in both countries and developing in existing ones. The parties note with satisfaction the existing partnerships which proved their value also during the COVID-19 pandemic (for example, on 28 May 2020, the mayor of the town of Szamotuły donated FFP2 masks to Sint Andries hospital in the partner town of Tielt).

16.1

The provisions of the present Co-operation Programme do not preclude the possibility of implementing other activities, exchanges or projects that will be agreed upon by the Parties through diplomatic channels.

Both Parties will agree on the provisions for each specific event through diplomatic channels. Any disputes concerning the interpretation or implementation of the present Co-operation Programme shall be solved by negotiations between the Parties through diplomatic channels.

16.3

Both parties agree that each Party is responsible for its own costs related to the exchange of experts.

16.4

The present cooperation programme takes due account of the Belgian competence division written in the Constitution.

The next meeting of the Joint Commission will be held in Brussels in the fourth quarter of the year 2023.

Done in Warsaw on the 22nd September 2021 in two original copies English and Polish, the two texts being equally valid. Should any differences in the interpretation of the Co-operation Programme occur, the English version shall prevail. The Flemish Party will provide a Dutch translation.

LIST OF PROJECTS

1. IN GENERAL

1.1. WO II Memorial in Roeselare and permanent expo in Poznan

Poland and Flanders (further as both Parties) will assist the local authorities of Roeselare in creating a Memorial about the liberation of Flanders by the First Polish Armoured Division. If necessary, both Parties will also support parallel initiatives such as a route through the liberated Flemish cities and a wall of fame with an indication of all fallen Polish soldiers.

1.2. Anniversaries or historical events

1.2.1 General Stanisław Maczek

- Screening of a film about General Maczek entitled Invincible, directed by R. Geremek.
 The film could be promoted in selected Flemish cities liberated by the 1st Armoured
 Division commanded by General Maczek, in collaboration with local institutions;
- Promotion of two books: Forgotten heroes (2020), co-authored by Dirk Verbeke and Johan Vande Voorde and a historical book that is now being prepared by Dirk Verbeke, about the trail of the Polish 1st Armoured Division commanded by General S. Maczek in Flanders;
- The Parties will make all efforts for the aforementioned publications as well as other
 publications describing the achievements of the Polish 1st Armoured Division, to be
 translated into other languages (Polish, English, French).

The partners would include: the Polish History Museum, the Association of the Polish First Armoured Division Belgium, Lannoo Publishers.

The Parties declare their readiness to support the activity of the Flemish Association
of the First Polish Armoured Division Belgium (Vereniging 1e Poolse Pantserdivisie
Belgie vzw), which for a number of years now has been preserving the memory and

- spreading knowledge in Belgium about the military achievements of General S. Maczek's Polish soldiers.
- The Parties declare their readiness to support the activity of the Reconstruction Group
 of the Polish 1st Armoured Division 'Antwerp', considering its founding an important
 element in commemorating the image of Polish soldiers who contributed to the
 liberation of Flanders in 1944.
- It would also be important to work together to support the development and preparation of the exhibition of photographs of the Polish 1st Armoured Division from the collection of a history enthusiast and long-time collector, Guy Lapers.
- Another project could be to develop historical material on the basis of 70 hours of talks conducted by Bart Verstockt with the deceased soldiers of the 1st Armoured Division commanded by General Maczek. B. Verstockt is the author of two documentary films about General Maczek's soldiers (Fighting for others, dying for Poland and Sylvester).
- One of the forms for these promotional activities may be to make use of cyclical meetings called "Przystanek Historia" 'Next Stop History' meetings, initiated by the Polish Embassy in Brussels and the Institute of National Remembrance in order to shed light on important events from the history of Polish Army, also during the II World War. There are plans to hold these meetings also in Flemish towns and villages liberated by General S. Maczek and his soldiers.
- The Parties will take common actions to organize a second edition of the Liberation Bike Ride a bike rally following the battle trail of the 1st Armoured Division of Gen. S. Maczek, a complex Polish-Flemish project carried out for the first time in 2019, on the occasion of 75th anniversary of liberation of Flanders by the 1st Armoured Division. The next edition could take place in September 2022, thus becoming part of celebrations in honour of the 130th anniversary of General S. Maczek's birthday. The aim of the event will be to commemorate this anniversary, promote Poland as a tourist destination, promote Poland and Flanders as places offering interesting bicycle trails and promote the bicycle trail marked out on the occasion of the first edition of the Liberation Bike Ride.

The main partners in the project would be: authorities of Tielt, the Polish National Tourism Office in Brussels, POC Partners, other organisations and institutions from Flanders and Poland interested in promoting bicycle tourism and topics related to the anniversary.

 The Parties are also interested in having information tablets placed along the Flemish trail of the First Armoured Division, in cooperation with the organisation Toerisme Vlaanderen and the Association of the Polish First Armoured Division. Such tablets were already placed in 5 locations in 2019 when organising the aforementioned 'Liberation Bike Ride' bicycle rally.

8. CULTURE, CULTURAL HERITAGE

8.1. Culture and cultural heritage

- 1. Both Parties support continued cooperation in the field of cultural heritage:
 - International Cultural Centre in Kraków in partnership with KU Leuven is carrying out a research project 'llucidare Building international connections for heritage-led innovations', which will last until 2022, with the intention of continuing cooperation with Flemish partners. The ICC is interested in finding a partner institution in Flanders with which it could design a joint exhibition or scientific project on issues such as: architecture and 20th century art, protection of cultural heritage and issues related to the management of historical cities (examples of Antwerp, Ghent and Bruges), cultural economics and cultural policy.
 - The Parties will encourage their institutions to carry out projects in the field of cultural heritage digitisation. They will work together to digitise documents relating to their common history and to make them available to the public.
- 2. Both Parties will support the development of cooperation in the field of research and presentation of Flemish painting:
 - Continuation of research on Hans Memling's Last Judgment in cooperation with museums with substantial collections of 15th century Flemish paintings (Sint-Janshospitaal and Groeningemuseum in Bruges, Museum voor Schone Kunsten

in Ghent, KMSKA in Antwerp) and with the Royal Institute for Cultural Heritage (KIK-IRPA) in Brussels;

- Cooperation with the Royal Library of Belgium (KBR) in Brussels on assembling
 a rich collection of ancient drawings and graphic art; KBR boasts an excellent
 collection of North European drawings and graphic art, and its staff has
 extensive knowledge and research experience in this field.
- Exhibition of Flemish paintings from the collection of the Wawel Royal Castle and publication of the collection catalogue. Exhibitions in the Flemish partner's museums are expected in 2023. A small-scale exhibition of 35 paintings will showcase the most valuable and interesting Flemish works from the collection of the Wawel Royal Castle. This little-known collection represents various painting forms: landscape (including seascapes), petit genre, religious, mythological and allegorical painting. The show will be complemented by large-format photographs (or a multimedia presentation) of the interiors of the Wawel Castle, where these paintings are displayed. The Museum is also willing to host exhibitions from Flanders from 2023.
- 3. Both Parties are interested in developing cooperation between cultural institutions from both countries:
 - The European Film Center CAMERIMAGE in Toruń would like to exchange experiences with the Flemish partners in the field of film production, including their preparation and presentation during film events.
 - Podlasie Opera and Philharmonic European Art Centre
 in Białystok would like to cooperate when it comes to exchanging professionals
 or organising study visits at the University of Antwerp as a model institution in
 the area of implementing e-learning processes.
 - The Polish National Radio Symphony Orchestra in Katowice (NOSPR) would like
 to continue its cooperation with Collegium Vocale Gent. The joint plans include
 an artistic residency of Collegium Vocale Gent in the NOSPR, including two
 concerts in 2022 and educational activities: open rehearsals and workshops.

- Furthermore, if conditions permit, NOSPR is planning a tour of the most important cities of Flanders between 2022 and 2023.
- The National Folk Song and Dance Ensemble Mazowsze would like to propose a project aimed at establishing cooperation with local amateur folk ensembles of Flanders. The actions would take place on two levels. The first would concern the promotion of Polish folklore by teaching Polish national dances, while the second would focus on artistic and creative cooperation, which would result in a joint development of Flemish folk dances. These efforts would culminate in a joint concert.
- The Polish National Song and Dance Ensemble 'Śląsk' in memory of Stanisław Hadyna proposes to strengthen cooperation as part of joint projects and workshops. Moreover, it plans to organise a concert tour in Flanders.
- Opera Nova in Bydgoszcz would be willing to take up cooperation in the scope of hosting opera and ballet performances by groups from Flanders.
- The Centre for Polish Sculpture in Orońsko has established contacts with the Middelheim Museum in Antwerp and has hopes for collaboration including, among others, mutual presentation of exhibitions.
- 4. The National Institute of Architecture and Urban Planning (NIAU) would like to discuss with its Flemish partners topics connected with the organisation of the tasks of public administration and professional environments aimed at establishing the broadly understood spatial order. The NIAU would like to benefit from the experience of Flanders in this scope, for example by organising an international seminar under the auspices of the NIAU and the Polish Architecture Council with the participation of architects and officials from the architecture administration of Flanders and their Polish counterparts, focusing on issues that would be useful for the formulation of Polish Architecture Policy.
- 5. The Book Institute proposes to carry out a project in Flanders entitled 'Polska Półka' ('The Polish Bookshelf') which consists in organising a separate catalogue or a physically separate shelf containing translations of Polish literature, books by Polish authors in the original language version as well as books about Poland,

including Polish history and culture, in the local language, in the public library network, with the involvement and support of local authorities. In the scope of the project, the book collections of participating libraries will be supplemented free of charge with books purchased by the local project partner, a non-governmental organisation, using financial support provided by the Book Insitute. The Polish Institute in Brussels will be involved in the whole process as co-organiser. The launching of 'polish shelves' in each library will be accompanied by a cultural programme with the participation of Polish authors, translators of their work as well as illustrators. Local communities will be the target group for all such events.

- 6. In connection with the 100th anniversary of the birth of Leopold Unger (2022) and the 90th anniversary of the birth of Professor Wojciech Skalmowski (2023), prominent figures of Belgian culture and also collaborators of the Paris 'Kultura' magazine, it is worth recalling the role and significance of this institution in the history of the 20th century.
- 7. As the International Chopin Piano Competition has been postponed until October 2021 for safety reasons due to the pandemic, Chopin's legacy remains one of the leading topics of cultural diplomacy, as does the promotion of the most prominent 20th century composers of Polish music such as Karol Szymanowski (in the context of the 140th anniversary of his birth falling in 2022), Wojciech Kilar (90th anniversary of birth in 2022), Witold Lutosławski (110th anniversary of birth in 2023), Krzysztof Penderecki (90th anniversary of birth in 2023) through strengthening cooperation with music festivals in Flanders in order to include works by Polish composers in the permanent repertoire of orchestras and festivals.
- 8. In the field of theatre studies, both Parties will support cooperation between the Polish Institute in Brussels and KU Leuven in organising Kantor workshops and presenting research by Polish scholars within the framework of the project 'Memory models in Polish theatre' (2021). Both sides will also strive to present to each other the most important theatre, opera and ballet shows.
