

**MINUTES OF THE NINTH MEETING OF THE JOINT COMMISSION  
BETWEEN THE GOVERNMENT OF FLANDERS AND THE GOVERNMENT OF  
THE REPUBLIC OF LITHUANIA**

**CO-OPERATION PROGRAM  
FOR THE YEARS 2019-2023  
IN IMPLEMENTATION OF THE CO-OPERATION TREATY  
BETWEENTHE GOVERNMENT OF FLANDERS AND  
THE GOVERNMENT OF THE REPUBLIC OF LITHUANIA**

**Vilnius, 6 November 2019**

The ninth meeting of the Joint Commission between the Government of Flanders and the Government of the Republic of Lithuania was held in Vilnius on 6 November 2019

The meeting was organised to agree a new co-operation program for the years 2019-2023. The Joint Commission implements with this text the co-operation treaty of 7 March 1996 between the two countries.

Both delegations, hereafter called the Parties, took also the opportunity to discuss a number of policy themes.

The Flemish party gave a brief explanation about the new Flemish government. She emphasized that the Flemish government intends to determine a list of historical and cultural Flemish anchor points, called Flemish canon. Some countries as Lithuania already determined a comparable historical memory. The Lithuanian party explained how this process happened.

Both parties discussed about a number of European themes such as the Brexit, the new European Commission and the multiannual financial framework (MFF).

The Lithuanian party explained the plans related to Kaunas Cultural Capital 2022.

## **1. ECONOMY, TRADE, INVESTMENT**

The Parties are prepared to examine ways of further optimizing their cooperation in the framework of the European open method of coordination (OMC) or the Organisation for Economic Co-operation and Development (OECD) between entities responsible for outlining and executing entrepreneurship policies

In the field of bilateral co-operation, the Parties will stimulate mutually beneficial exchanges and co-operation in entrepreneurship policy. They will search for suitable occasions for contacts among scientific institutions, companies, universities and administrations that are in charge of entrepreneurship.

Flanders is interested in logistics and transport and aims for cooperation between companies in the field of ports and the development of the Rail Baltica Project.

The Parties are interested in attracting investment, implementing investment projects, cooperation between private and public sectors (the so-called Private-Public Partnership (PPP) projects), promotion of small and medium sized business.

The Parties are committed to enhancing and promoting the trade relations between Lithuania and Flanders. For that purpose, they will exchange information regarding business and investment opportunities. Ad hoc, and at the request of the other Party, they will also exchange information regarding its market and sectors, useful contacts, experiences and knowledge concerning the promotion of international entrepreneurship. Moreover, the Parties want to encourage cooperation between Flemish and Lithuanian start-ups.

## **4. CULTURE**

### **4.1 Culture policy**

The Parties will inform each other in an active way concerning important developments in cultural policies. That means that the Parties will keep each other informed, on a regular basis, of policy matters and their international context, including the identification of the stakeholders involved and references to other sources that may be available.

When common subjects of considerable present political importance have been detected, the Parties may decide by consensus to organize specific projects in that field, such as exchanges, training, on the job training, seminars, residencies.

### **4.2. Arts and culture**

The Parties will encourage networking and direct cooperation between institutions, organizations and experts of professional performing arts, visual art, literature, cinema, architecture, design and cultural heritage (libraries, archives and museums).

Both Parties would welcome initiatives in respect of residencies as residencies for artists, writers, translators and other creative professionals are an excellent instrument to stimulate contacts and exchanges.

#### **4.3. Cultural Heritage**

The Parties will encourage networking of cultural heritage institutions (libraries, archives, museums) for the purpose of exchange of knowledge and good practices, experts and competences concerning the preservation, sustainable use, promotion and digitization of tangible and intangible cultural heritage.

The Lithuanian side is particularly focusing on management and monitoring of tangible and intangible cultural heritage as well as on cultural heritage education and installing digitization in presenting information at cultural heritage sites.

For the Lithuanian side museum cooperation in the field of exchange of collections, museum management and museum educational programmes development, as well as cooperation between restorers in the field of preservation and restoration, are important issues. In the field of archives the focus is on the organization of specific projects, the exchange of archives related information, experts and competences on professional development, legislation relevant to archives, preservation of analogic and digital archives and archival information systems.

On the Flemish side the museum sector is open to opportunities, demands and news from the Lithuanian side.

#### **4.4. Multilateral framework**

Both Parties will cooperate in the field of culture and cultural heritage in the framework of the multilateral organizations and fora, European and global, such as the European Union, the Council of Europe, UNESCO, etc Both Parties participate in related working groups, exchange best practices and look closer into opportunities for common projects.

The Lithuanian side informs that Kaunas was selected as the European Capital of Culture 2022. In this regard, both Parties will encourage cooperation between Kaunas and the Flemish city Kortrijk especially in the fields of design and modernist architecture regarding the UNESCO Creative Cities Network (creative field: Design) and the programme "Modernism for the future" of the project "Kaunas – European Capital of Culture 2022".

**10. GENERAL AND FINANCIAL PROVISIONS**

The Parties shall send their proposals for the new co-operation Programme at the latest six weeks before the date foreseen for the meeting of the joint committee.

They agree that their future co-operation should be developed in as concrete as possible, starting from realistic projects.

The following general provisions and regulations were endorsed:

- all activities and exchanges mentioned in this Programme shall be carried out within the limits of the financial resources at the disposal of the two Parties,
- the activities and exchanges envisaged in this Programme shall not exclude other initiatives or visits which might be proposed and agreed in advance by both Parties through diplomatic channels or by direct mutual agreement,
- the organisation of music, dance and theatre performances and exhibitions, other than those mentioned in this programme, should a priori be based on a direct agreement covering financial and other terms between the organisations and artists involved in such events,
- both Governments are free to subsidise specific projects as well.

Other conditions are to be agreed upon by the partners on a case by case basis.

## 11. FINAL PROVISIONS


The Parties shall agree on the conditions for each specific event through diplomatic channels or by direct mutual agreement.

All disputes concerning the interpretation or realisation of this Programme of activities shall be settled through negotiation between the Parties

The Parties agree to hold the next meeting of the Joint Commission in Brussels during the second half of 2022.


